PUBLICATION AGREEMENT

This Agreement is made between the Author(s) set out above (I, Me and My) and The London Mathematical Society on the date set out below.

This Agreement distinguishes between the Original Article as submitted by me to the LMS Journal of Computation and Mathematics (LMS JCM) for publication; the Definitive Article which is the body of the article as published by the LMS JCM; the Abstract (which includes the volume and page references to the LMS JCM and a link to the definitive article); and the Add-Ons, being other electronic items (such as programs, databases, erratum lists, critical discussions, etc.) that are published by the LMS JCM as attachments to the definitive article. I agree to publication of this article in the LMS JCM. I understand that by this Agreement I am accepting the following terms:

- 1. I retain copyright in the Original Article, including all moral rights.
- 2. I undertake that I shall not grant to any other person permission to reprint the Original Article, or distribute it so as adversely to affect the LMS JCM, until it has been published in the LMS JCM. I also undertake that after publication, any copy of the Original Article, or a substantial part of it, which I distribute or make available publicly will contain on its first page or in its introductory material a reference or link to the definitive article, naming the LMS JCM and the volume and page numbers.
- 3. I grant the Publisher an irrevocable, world-wide, non-exclusive royalty-free licence for the publication of the Definitive Article and Add-Ons in the **LMS JCM**. In so doing I give the Publisher sole right to do the following:
 - (a) to make electronic or printed copies of the Original Article, the Definitive Article, the Abstract and the Add-Ons for purposes of publishing and archiving the **LMS JCM**;
 - (b) to alter the Add-Ons to the article, at the sole discretion of the Honorary Editors, in order to increase the usefulness of the article to the **LMS JCM**'s readers, so long as these changes do not obscure or distort my contribution to the work;
 - (c) to distribute or make available copies of all or parts of the Definitive Article, the Abstract and Add-Ons to individual and corporate subscribers to the **LMS JCM** and to grant these subscribers, and the members of the corporate subscribers, sub-licences to make further copies on terms stated by the Publisher as amended from time to time;
 - (d) to distribute or make available copies of all or parts of the Definitive Article, the Abstract and Add-Ons to document delivery services, interlibrary loan schemes, abstracting journals and the like, on terms to be agreed by the Publisher;
 - (e) to make the Abstract freely available in full;
 - (f) to include the Definitive Article, the Abstract and Add-Ons in mirror sites for purposes of (c)-(e) above;
 - (g) to deposit copies of the article, in whatever format is appropriate, at libraries of record;
 - (h) to make such changes as are reasonably necessary in the sole opinion of the **LMS JCM** in order to remedy any breach of copyright that comes to light after publication.

- 4. The Publisher undertakes to use reasonable efforts to make the Definitive Article and Add-Ons available (technology permitting) to all individual and corporate subscribers to the LMS JCM, through the Internet.
- 5. Except as provided in clause 3(h) above, the LMS JCM undertakes to make no alterations whatever in the Definitive Article, from the time of acceptance, except such changes as are reasonably required to update the electronic format or medium or to migrate the article to a different electronic delivery mechanism; and to take reasonable technical and legal steps to protect all parts of the article from unauthorised alteration.
- 6. If the **LMS JCM** has agreed with me that certain items of software or computing facilities are needed for use of the Add-Ons and should be made available with the article, then the **LMS JCM** undertakes so far as is reasonably possible to maintain the availability of these items or facilities.
- 7. I warrant that the material does not contain any defamatory matter or infringe any existing copyright. Furthermore I warrant that permission has been obtained from the copyright holder for any material not in my copyright and the appropriate acknowledgement made to the original source. I attach copies of all permission correspondence.
